I don't have a computer or printer at home.

How can I get a copy of the Mail-in Rebate Form?

Have multiple copies of the Mail-in Rebate Form available in your store to distribute to customers who ask this question. Simply copy the back of this sheet.

Can I submit more than one (1) Rebate Claim if I purchased multiple products?

No, this offer is limited to one (1) Rebate Claim per household.

Can I submit both an Online Rebate Form and a Mail-in Form?

No, you may submit either an Online Rebate Form or a Mail-in Rebate Form.

What are the date requirements for Rebate Claims?

- Products must be purchased between 1/1/20 and 5/31/20
- Mail-In Rebate Requests must be postmarked within thirty (30) days from date of purchase and received by 7/16/20
- Online Rebate Requests must be submitted by 6/30/20

I purchased a Preen Weed Preventer product that is not listed on the Rebate Form. Is that eligible for the rebate?

No, only the Preen products listed on the Rebate Form are eligible for the rebate.

The Preen Weed Preventer product I purchased is listed on the Rebate Form, but at a different size. How do I know if that is eligible for the rebate?

Do I need to include the actual Proof of Purchase/UPC code from the product package?

No, you do not need to remove the UPC code from the Preen package. Simply enter the 12-digit code into the Rebate Form.

Can I submit a copy of the store receipt?

If you submit the rebate claim online, you will have to take a picture of the original store receipt with the name of the retailer, date and product purchased clearly visible. If you submit the rebate claim via the U.S. Mail, you will be required to submit the original store receipt with the name of the retailer, date and product purchased clearly visible.

What if I need my original store receipt for a different manufacturer's rebate offer in addition to the Preen Mail-in Rebate Offer?

You should request a duplicate original store receipt from the retailer.

Can I submit a PO Box Address on the Rebate Form?

No, only street addresses will be accepted for a rebate claim.

I cannot/do not receive mail at my street address.
